- FEI Rules for Jumping Events, 24th edition, updates effective 1 January 2012
- FEI Dressage Rules, 24th Edition, 01 January 2011
- FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMR), 1st Edition, effective 5 April 2010. Updates effective 1 January 2012
- FEI Anti-Doping Rules for Human Athletes (ADRHA), Based upon the 2009 revised Code, effective 1st January 2011.

II. GENERAL RULES AND REGULATIONS

ENTRY FEES

Entry fees for each class are shown in the competition schedule.

ENTRY CLOSING DATE

All entries must be made using the prescribed forms attached. Entries must reach the Organiser's Address before or by the **3rd of May 2012**. Entries received after **3rd of May 2012** will be considered as Late Entries. A late entries fee is 50% the normal entry fees. Entries may be made in person, by post, fax or via internet to secretariat together with waiver and liability form.

ENTRY CANCELLATION

Entries cancelled after the closing date must be verified with a Veterinarian Medical Certificate for a refund of the entry fee.

CASH PAYMENTS

All cash payment should be made to the secretariat office.

EFI RIDER LICENSE

All riders have to have EFI rider License. No riders are allowed to compete without EFI rider license. License and EFI horse passport information and forms can be downloaded from here:

WAIVER FORM

Waiver form must be signed by each rider participating in the event. Riders under the age of 18 must have guardian consent. To be returned with entry forms.







GENERAL CONDITION

You are provided with plastic trash bag for the deposition of dung and other refuse. The dung must be removed from the sawdust daily and disposed of in a proper manner. At the end of competition, all stables must be cleaned of all dung and left over feed. The stables and other areas occupied by participants must be kept clean and tidy at all times. You are not to burn sawdust or any other material inside the stable. Cooking inside the stable is not permitted.

WELCOME DINNER

All riders and officials are invited to the welcome dinner by PAZIA Pillar Mercycom at Limolian Cafe, Arthayasa Stables Cinere – Depok, Indonesia held on the **12th May 2012 at 07:30 PM**.

STABLING FEES

Rp 150.000,- per horse per day. To be paid to the Event Secretariat. Horse will not be allowed to leave the permises until the stabling fees have been paid.

RULES OF COMPETITION

The competition will run under the Fédération Equestre Internationale (FEI) and Equestrian Federation of Indonesia (EFI) rules. In any circumstance where FEI or EFI rules are not available the Organizing Committee will have the authority to make decision.

PRIZE GIVING CEREMONY

Placed riders that do not attend their prize Giving Ceremony will not received their prizes.

IN-HOUSE RULES

All riders are expected to wear a hard hat, riding boots and shirt when on the horse. The competition grounds and stables area must be kept clean and tidy at all times. Washing down horses should be done in the washing bays only and not inside the stables. Cooking inside stables modules will not allowed.

You are provided with plastic bag for disposal of dung and other refuse. The dung/waste must be removed from the sawdust daily and disposed of in a proper manner.

At the end of the competition, all stables must be cleaned of all dung and waste.

THE OC RESERVE THE RIGHT

• Alter advertised times if necessary • Cancel or divide any class or event • Refuse any entry • Increase or decrease the height of the obstacles depending on the entries or other conditions

APPEALS

Complaints and appeals must be in writing to the **President Ground Jury**, signed by the authorized person from the club making the complaint and presented personally the appeal committee together with any supporting note evidence and names of witnesses and the deposit of **Rp. 1,000.000,-**. Complaints must be made not later then 30 minutes after the result are announced. If the complaint is







accepted OC will refund the deposit conversely if the complaint is not accepted the deposit will remain with the OC. Refer to the FEI Art. 167 Of General Rules & regulations for more details.

VET INSPECTION

Vet inspection (trot up) for the FEI Jumping World Cup, SEA League horses will be held on the **10th May 2012** at **16:00** behind the Judge Box

INSURANCE

All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents and their horses. They are therefore strongly advised to take out third party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep their policy up to date.

HORSE NUMBERS

Horse Numbers are not distributed by the organizer. Riders are responsible for displaying the correct number on their horses at all time. The numbers can be purchased in the secretariat.

III. JUMPING RULES & REGULATIONS

Classes are judged under the FEI rules. For the in-house rules read below.

- 1. OPEN classes are open for riders of all ages and horses of all grades
- 2. PRELIMINARY classes are open for preliminary (not experienced) riders only
- 3. CHILDREN classes are open for the riders under 14 years old
- 4. JUNIOR classes are open for the riders under 16 years old
- 5. YOUNG rider classes are open for the riders under 21 years old
- 6. Riders entering CHILDREN, JUNIOR or YOUNG RIDER classes have to submit (one time) **copy of the passport** to the secretariat together with entry form
- 7. Riders will be **eliminated** if enter the class of **wrong age category**
- 8. In the NON-JUMPOFF classes BELOW 1m one horse can be ridden by maximum three (3) riders
- 9. In the classes BELOW 1m three (3) refusals are allowed



IV. RULES FOR THE FEI WORLD CUP™ - SOUTH EAST ASIAN LEAGUE

FEI World Cup for Jumping 12th Edition, effective 1st of May 2009 (revised 21 November 2011)

These rules are to be read in conjunction with the FEI rules for the World Cup for Jumping. Where these rules are silent, FEI rules prevail.

PART A - COMPETITION

- 1. Maximum number of competitors in each qualifier is 35
- 2. A rider can ride more than one horse. In such case the horse going for World Cup points must be declared before the start of the competition, and the rider must ride that horse first.
- 3. If there are more than 30 nominations, the organizers have the right to restrict riders to one horse. If on the day of competition there are fewer than 30 starters, the Organising Committee may decide to allow the second horse to start.
- 4. All competitions must be (art 238.2.2), which is one round competition not against the clock, with a time allowed and with one jump-off against the clock, unless express, written permission is given for any other type of competition.
- 5. The time alowed is to be based on 350 meters/minute for indoor competitions. Outdoor competitions must be run at a minimum speed of 350 m/m and may be run at speeds up to 400 m/m where conditions permit.
- 6. Rider must wear protective headgear in accordance with the prevailing rules of the country that the competition is run in.
- 7. Veterinary inspections (trot-up) and swabbing (drug-testing) are compulsory at all World Cup shows, and are the expense of the Organising Committee of that show.

PART B – TECHNICAL RULES

- 8. A height of the obstacle is to between 1.40m to 1.60m, with spread of not more than 2.0m, unless permission is grante by the Foreign Judge at the competition.
- 9. Cups must not exceed 22mm in depth.
- 10. Wooden poles must be used. They must be round, and should weight no more than 15 kg each.
- 11. Safety cups are to used for the back poles of spread fences.
- 12. Electronic timing with display is compulsory and must be recorded in 1/100 of a second. A countdown timer for the start is compulsory.
- 13. Qualifiers are considered competitions open to horses all grades.

PART C – ADMINISTRATION

- 14. Riders of any nationality may compete in the South East Asian League
- 15. Non-SE Asian nationals must obtain a license from their home National federation to ride in the SE Asian league
- 16. The South East Asian League reserves the right to exclude non-South East Asian Nationals from competing in this league, not withstanding rules 15 and 16 above.
- 17. Riders who have a league in their country of citizenship, have competed in any other World Cup League (e.g Australian or Japanese league), or intended to







compete in any other World League, must inform the South East Asian League, before the competition begins, which league they wish to score points in.

- 18. A completed FEI Passport or national passport that is approved by the SE Asian League must be presented before a horse is allowed to start in a World Cup qualifying competition.
- 19. Prize money is at discretion of the organizing committee for each qualifier.
- 20. Entry fees may not be more than US\$100 per qualifier and may be set by the Organising Committee.
- 21. Final Entries are to be confirmed by the South East Asian League.
- 22. The Chairman of the Ground Jury must be an FEI Official International Judge or International Candidate Judge from the approved panel of judges for the SE Asian League. All his expenses including flights, hotel accomodation and laundry are for the expenses of the Organising Committee of that show.
- 23. The foreign judge for each show will be appointed by the Equestrian Federation of Indonesia in conjunction with the FEI. All his expenses including flights, hotel accomodation and laundry are for the expenses of the Organising Committee of that show.
- 24. The Course Designer must be an Official International Course Designer, International or International Candidate Course Designer from the approved panel of Course Designer for the SE Asian League. All his expenses including flights, hotel accomodation and laundry are for the expenses of the Organising Committee of that show.
- 25. The Course Designer for the South East Asian League Final (final qualifier) will be appointed by the Equestrian Federation of Indonesia All his expenses including flights, hotel accomodation and laundry are for the expenses of the Organising Committee of that show.
- 26. There shall be at least four judges officiating. The chairman of the Ground Jury shall be approved as per rule 24 above. Other judges must be from the FEI list of judges, or national judges approved by the SE Asian League.
- 27. Draft schedules including names of all officials are to be submitted to the Administrative Coordinator not less than 10 weeks prior to the event.
- 28. All schedules and officials must be approved by the FEI and the League Executive. No officials may be invited until they have been approved.

PART D – REPRESENTATION AT THE WORLD CUP FINALS

- 29. The South East Asian League Winner shall be the rider who is leading the points table after the competition of all qualifiers (including SE Asian League Final) who is of a South East Asian Nationality or who has been approved by the FEI as a rider in the South East Asian League.
- 30. The SEA League Winner must inform the Administrative Coordinator, not later than one week after the last qualifier, if he/she intends to compete at the World Cup Final.
- 31. In the event that the leading rider decline to compete in the World Cup Final, the opportunity may be offered to the rider who places second on the final points table, then to the rider who places third. No rider who places lower than third may compete at the World Cup Final unless in exceptional circumstances agreed between the SE Asian League and the FEI.
- 32. As soon as possible after the rider has notified his intention to compete at the World Cup Final, arrangement will be made for a compherensive veterinary







examination to be carried out (at the expense of the rider) by a veterinarian nominated by the League. No rider will receive funding from the League to compete at the World Cup Final.

- 33. The SEA League representative shall ride in the World Cup 'B' finals the weekend before the World Finals proper. The FEI's World Cup Committee will decide if, based on the results in the 'B' finals, if our rider will be allowed to start the World Cup Finals proper.
- 34. The League winner shal be entitled to attend the World Cup Final as a spectator to receive his League prize, should he/she choose not to participate as a rider.

GENERAL

35. The South East Asian League reserves the right to amend, change and/or add any new rules as it sees fit as the league progresses.

V. DRESSAGE RULES & REGULATIONS

Classes are judged under the FEI rules. For the in-house rules read below.

- 1. OPEN classes are open for riders of all ages and all horses
- 2. Callers are permitted during test
- 3. No horse may take part with more than one rider in the same class/day/competition (except for Walk-Trot class and rider under 16 years old)
- 4. In Walk-Trot class one horse can be ridden by up to 3 riders

Dress Code

- 1. **Headgear.** Top hat is allowed in Medium and above classes. In other classes <u>Hard</u> <u>Hat (Helmet)</u> is compulsory for anyone riding at the event.
- 2. **Dress.** White, light colored or black <u>gloves</u> are <u>compulsory</u>. White or light colored breeches, white stock or tie, black riding boots, a dark colour jacket are required when competing and <u>during the presentation of prizes.</u>
- 3. **Spurs.** Spurs capable of wounding a horse are forbidden. Spurs must be of smooth metal. There must be a shank pointing only towards the rear, which must be no more than 3.5 cm long. The end must be blunt in order to prevent wounding a horse. If the shank is curved, the spurs must be worn only with the shank directed downwards.
- 4. Whips. Whips up to 120cm length are permitted to use during the tests.
- 5. **Boots.** In all Tests, boots (other than as part of regulation service dress) must be black. They must either be long boots in one piece or a full grain smooth leather leg piece and leather boot.
- 6. **Bits.** Snaffle bridle compulsory for all dressage tests up to and including Elementary level. In Medium and Advanced level double bridle optional, Prix St. Georges compulsory. If using double bridle, spurs must be worn.
- 7. Walk Trot Tests. Simple side reins and whips up to 110cm length are permitted.

VI. VETERINARY REGULATIONS FOR TEMPORARY IMPORTATION OF HORSES INTO INDONESIA

HEALTH REQUIREMENTS FOR THE IMPORTATION OF EQUESTRIAN HORSE(S) FROM GERMANY INTO INDONESIA

(Empowered Law No. 18, 2009, Law No. 16, 1992, Government Regulations No. 15, 1997, Government Regulations No. 82, 2000)

A. CERTIFICATE OF HEALTH OF ORIGIN

The importation of animals must be acompanied with an original health certificate, issued by an Authorized Veterinarian of Government of the country of origin certifying that:

1. The country is free from African Horse Sickness, Western and Eastern (equine encephalomyelitis), Venezuelan equine encephalomyelitis and St. Louis equine encephalomyelitis for at least three years and do not have vaccination programmes for these disease.







- The horse since birth, kept in a part of properties (farm) known to be free of stangles/adenitis streptococcolis, Japanese encephalitis, surra and equine piroplasmosis, equine encephalomyelitis for the previous 2 (two) years.
- 3. The animals since birth, kept in a part of properties (farm) known to be free for the privious 2 (two) yers of **strangles/adenitis strepococcolis**, **Japanesse encephalitis**, **surra and equine piroplasmosis**, **EVA/equine arterities** (the test for EVA with negatives (-) result shall be attached in the health certificate)
- 4. The animals should be born and reared in the farm of origin that is free for at least six months from dourine, rabies, equine influenza (virus type A), glanders, equine rhinopneumonitis, echinococcosis/hydatidosis, strangles, mange and salmonellosis (S. Abortus equi).
- 5. The horses have been in a country or the properties (farm) of origin that is officially free for at least three months from Contagious Equine Metritis (CEM), Equine Infectious Anemia (EIA) and they must be subjected to serelogical test (EIA by Coggin's Test), for these above disease with negative result during 30 days prior to shipment. Those tests should be down at the Government Laboratory and the result should be attached in the certificate.
- 6. The animals have been recognized from the properties (farm) as being free from equine coitl exanthema and ulceratives lymphagitis.
- 7. The animals were kept in country or zone that is free of anthrax for at least six months or since birth.
- 8. The animals were kept in an establishment in which no clinical sign of *leptospirosis* was officially reported during 90 days prior to shipment and they were injected with 25 dihydrostreptomycin per kg of live body weight, the first injection being given 14 days prior to shipment and the second on the day of shipment.
- 9. The animals should be vaccinated against clostridial disease with tetanus vaccine, against equine influenza and equine rhinopnemonitis between period not more than 30 days prior to shipment and not less than 7 days prior to shipment and they have been treated for endoparasites at least on the day of shipment. If any wounds found should be treated prophylactically with an officially approved oily lavarcide as recommended dose.
- 10. The horses were kept in a quarantine station for 14 days prior to shipment, and were not in contact with swine and protected against vectors and treated against external parasites and endoparasites within 14 days prior to shipment and totally free of ticks.
- 11. The animals are showed no clinical of infectious and contagious disease and free from ectoparasites on the day of shipment.

B. OTHER CONDITIONS

- 1. All isolations facilities for this purpose shall be approved by a govenment veterinary officer.
- 2. The implementation of tests and treatment as mentioned above must be under direct supervision of authorized veterinarian of country of origin.
- 3. Any animals showing evidence of pink eye or visible genetic defect, cripple and wounds shall be taken out from the herd and rejected to be loaded.
- 4. The original certificate of health must be handed over to the captain/skipper, while its copies to the Indonesian Representative in country of origin.

C. TRANSPORTATION

1. The ship which will be used for carrying those horses shall be in clean condition.







- 2. The journey from the exporting port in country of origin up to the port of estination in Indonesia shall take direct route with no intermediate stop or by approval of DGLAHS.
- 3. If the intermediate stop between the journeys from the exporting port in Germany up to the port of destination in Indonesia is permissible, the horses shall remain on board.
- 4. The ship/aircraft is not allowed to carry other animals other than the approved animals. Exeption is permissible with the approval of DGLAHS.
- 5. Provision of fodder must be sufficient for the journey and for adaptation period of 4 days in the quarantine station in Indonesia. Provision of drinking water shall be according to country of origin regulation.
- 6. Those which are developing "*pink eye*" during the voyage/journey have to be treated immediately with recognized treatment according to the registered direction.
- 7. If any outbreak of these diseases (African horse sickness. Venezuelan equine encephalomyelitis) occured during the journey the ship is not allowed to approach at any ports of Indonesia. The whole animal consignment is rejected.
- 8. In addition to ship's crew attendants who will take care of exported animals during the journey shal be provided.
- 9. The skipper shall submit the documents relating to the animals to the Animals Quarantine Officer at port of destination of Indonesia a.o:
 - (1) Certificate of health as mentioned in clause I
 - (2) Identification list of animals concerned.
 - (3) List of mutation of animals on board it can be made separetely or included in animals list
 - (4) List of loaded equipment, drugs and fodder.

D. QUARANTINE MEASURES IN INDONESIA

- 1. On arrival at the port destination, the Animal Quarantine Officer conducts inspection of documents and health of the animals on board of the ship.
- 2. Permission to unload the animals shall be granted if these animals are found to be healthy and the accompanying documents are complete and in order.
- 3. Following disembarkation the imported animals shall be detained at an approved quarantine station for a minimum period of 14 days under supervision of the Animal Quarantine Officer. During this detention period obligatory, inspection and treatment are carried out.
- 4. If it is deemed necessary the quarantine period may be reduced or extended. In this case the Animal Quarantine Officer should compulsory to make preliminary notice to the Director General of Livestock and Animal Health Services (DGLAHS) and to Chief of Centre for Animal Quarantine concerned via telephone. The DGLAHS is entitled to decide the reduction or extension of the quarantine period.
- 5. On completion of the quarantine the animals shall be releases providing they are free from infectious and contagious disease.
- 6. Upon release from the quarantine the animals shall be kept separately from other livestock at a place and for a period as determined by veterinary officer of local government.

E. OTHER REQUIREMENTS / INFORMATION

Upon completion of the show/competition, the horse shall be exported back to its country of origin within 14 days after the competition/show participated ends.









PROCEDURE FOR URINE COLLECTION (MCP) VII.

- (1) The Official Veterinarian will direct the horses to the collection centre for the testing. He/she makes all the decisions regarding collection.
- (2) Selection of horses will be:
 - a. At random
 - Some of the winners and placed horses b.
- (3) The individual clubs' handlers will lead the horse and they must remain with the horses until the horse have urinated.
- (4) The urine sample collected from each horse will be identified, certified and coded. The handler and the official in charge of the urine collection will jointly sign to certify the above procedure.
- (5) The urine sample will be split into 2 bottles; coded, taped and sealed in the presence of the handler.
- (6) The results of the analysis will be sent to the Organiser and to the Equestrian Federation of Indonesia (EFI)
